#### **Project Summary**

JoinMe2 Project aims at equipping Higher Education (HE)
instructors with the necessary competence in equality and
diversity so that they promote a learning environment that is
conducive to learning. If a student feels uncomfortable, unsafe, or
not respected, then their chances of success dramatically
decrease. As a result, this situation hinders students' ability to
fully participate in society as independent and responsible
citizens.

- Output 1: Inclusive Education: descriptive and comparative analysis
- 1) The empirical surveys will help us identify existing attitudes and beliefs towards the concept.
- 2) The country-specific study texts derived from the collected data will reveal the situation in all partner counties.

## Output 1: Inclusive Education: descriptive and comparative analysis

• All partner countries will be responsible for writing their own chapter for the publication of "Inclusive Education: descriptive and comparative analysis". Therefore, each institution will have to involve both students and instructors during the data collection stage by conducting surveys. The expected number of the instructor participants is 600 (100 x 6 partner institutions) and expected number of students involved is 3000 (500 x6 partner institutions). In terms of participant selection, the principle is to gather data from as many individuals as possible; thus, all partner institutions will distribute the survey to all faculty members and undergraduate students. The numbers mentioned above are based on expected survey returns.

#### Survey Preparation Process

- Survey Design
- Aim of the surveys is to elicit the attitudes of instructors and students towards the 5 diversity types. Especially the attitudes of instructors/teachers is thought to have an indirect affect on how instructors go about students from any of the diversity groups.

#### Sample Surveys

- «I think, having students from various cultures causes problems in my class»
- «Academically, I think boys do better than girls in class»
- «Having gay students in class make me nervous»
- «I don't like doing pair work with disabled students»
- «I am less patient with individuals of certain cultural backgrounds»

- We need one scale consisting of items adressing all five diversity topics.
- 8 items for each diversity type (all in English)
- One scale for instructors one scale for students
- We already exceeded the deadline so this has to be done ASAP
